Message from the Chair

After two years of Covid cancellations, at last we were able to gather for The Fund's 45th AGM in Adelaide on 9 September 2022 at the Queen Adelaide Club.

However, with the momentous news of the death of Her Majesty Queen Elizabeth II, proceedings commenced with two minutes silence for Her Majesty. Alan Smith, Chair of the South Australia Committee, then read a message from the Governor of South Australia. Fund Members were invited to sign the condolence book at Government House. In the evening, Alan proposed a toast to the late Queen and, to King Charles III at the Annual Dinner at the Adelaide Club. It was a day to remember.

It was wonderful that so many Members were able to attend the meeting in person. It was a great pleasure to welcome The Fund's founder, Tamie Fraser AO to the meeting as well as former Chair Richard Griffin AM.

On behalf of The Fund, I thanked Carolyn Forster OAM, Councillor and Chair ACT Committee who retired after 9 years service. A member since 1997, Carolyn is a stalwart supporter of The Fund. With her Committee, Carolyn has staged three AGMs as well as organizing The Fund's involvement with Open Days at Government House and the volunteer-led Garden Tours of the Government House grounds. We welcome Professor Robin Stuart-Harris to The Fund Council representing the ACT.

As is customary for the AGM, The Fund received a letter from the Governor–General and a letter from the Prime Minister. Both letters are very appreciative of The Fund's contribution, through its Collection, to the presentation of the Official Residences and their landscapes. The outstanding generosity of The Fund's Members and supporters is warmly acknowledged. I am pleased to share extracts from the letter from the Governor–General and a letter from the Prime Minister below.



Key to the success of The Fund are our relationships with the Office of the Official Secretary to the Governor–General and the Department of Prime Minister and Cabinet. These relationships are specified in the new Memorandum of Understanding which has been in place since 2020 is working very well.

Conservation is but one of many highlights in Sonya Abbey's *Report of the Fine Art Advisor*. Indeed, a formal vote of commendation and thanks was passed by the meeting in recognition of Sonya's contribution to The Fund, evident in the high standard of her detailed Report.

The key message of my address was the importance of ensuring The Fund's future as a thriving, sustainable organization. Members are the foundation of all that we do – we are a membership organisation and our fundraising ensures that Australia's Official Residences reflect the best of Australia's shared history and culture in the artworks on display and in use as a working collection.

I reflected on the fact that this was our 45th AGM and, that on 30 August, the Council met for the 168th time. This is a proud record of sound governance and achievement by The Fund and we should be conscious – especially at the AGM when we were joined by The Fund's founder Tamie Fraser AO – that we are continuing a legacy of quiet philanthropy – no grand halls with donors' names, no plaques – and, a legacy of patriotic philanthropy – generosity inspired by love of country – love of Australia.

The challenge for us as an organization is to ensure that The Fund's legacy continues and, to that end the Council's overarching goals for the next year – indeed for as long as it takes – will be firstly, to build our Endowment so that The Fund is sustainable and can continue to develop and care for its Collection; and secondly, to increase our Membership in line with our Articles of Association so that we continue to welcome new Members to help fulfill the purpose of The Fund. The increasing activities of the State Committees are essential to this goal and I thank all the Committees for their contribution to The Fund's longevity.

The Adelaide AGM was an absolutely delightful event, all due to the terrific program and warm hospitality which we experienced throughout the three days – from the heritage of the Barossa Valley's wineries to outstanding historic houses and inspiring gardens – with a special nod to The Fund's now quite tall tree at Anlaby planted by former Chair Donald McDonald 8 years ago.

Heartfelt thanks to Alan Smith and to his for their detailed planning of such a convivial range of experiences and, for showcasing the very best of Adelaide's distinctive strengths – heritage, landscape, very special wine and delicious food! Most importantly, we were able to gather again in each other's company after a long period of separation and can look forward to the 2023 NSW AGM to be held in the Southern Highlands.



Collection Update - Current Conservation Projects

As a 'working collection', The Fund artworks are on loan to the Official Residences for use and display. With the assistance of the House staff and our Conservators in Canberra and Sydney, we aim to make regular assessments of the condition of every artwork every 18 months approximately.

The proceeds from this year's National Raffle will be allocated towards conservation, in particular the Yarralumla cabinet by Geoffrey Hannah OAM (pictured right) which will be assessed for preventative conservation including a deep clean and re-waxing.

Annual General Meeting, Adelaide, 9 – 11 September 2022



Members and Supporters at Anlaby, September 2022

The South Australian Committee was delighted to welcome 80 members and supporters to the AGM held from Friday 9 - Sunday 11, September. The three days had been planned to provide a quintessentially South Australian series of experiences, most of which would not have been available to the casual visitor. After the long three-year gap since the last AGM, everyone threw themselves into it with gusto. The happy buzz of conversation was only stilled during the fascinating talks and the many delicious meals and wine tastings which regularly punctuated the (relatively) mild Spring days.



Our plans of course were affected by the very sad news of the death of Her Majesty Queen Elizabeth II, in the early hours of Friday morning. Government House advised that our scheduled reception that evening had been cancelled due to the Official Mourning. We were however very kindly invited to attend Government House to sign the Condolence Book and I was provided with a statement from Her Excellency the Governor, to read out on her behalf at the beginning of our AGM meeting at the Queen Adelaide Club and we observed a two-minute silence in tribute to Her Late Majesty.

Following an excellent lunch at the Queen Adelaide Club, we made our way by bus to the North Adelaide home of Fund Member and former Councillor, Deborah Hamilton, who generously opened up her beautiful house and garden for us all to enjoy. Not to mention providing us with a lavish afternoon tea. By now you will have noticed that food and drink were a prevalent theme throughout. Our first day concluded with an extended pre-dinner drinks gathering followed by the Annual Dinner both at the Adelaide Club. During the evening, our Chair Jennifer Sanders gave a gracious address thanking everyone for attending and I had the honour of proposing a toast to memory of Her Majesty Queen Elizabeth ||and a toast our King, His Majesty Charles III.

Day two was spent in the Barossa Valley which was looking wonderfully green and lush after the best season we have had in years. The day was designed so that the three venues we visited would together tell the story of how the landscape, indeed the very soil itself, the vignerons and their workers, the very functional heritage buildings, the distinctive food traditions and above all – the extraordinary continuity as five or six generations of winemaking families – all interact to create a region unlike any other in Australia.

Our first port of call was the Barossa Cellars, the newly created centre of the Barons of the Barossa, whose massive cellars built into the side of a hill, are home to what will be a decades long experiment and programme of testing and analysing the results of long cellaring of a wide variety of wines. All of which have been donated by the various vignerons of the Valley. Louisa Rose, the current head of the Barons gave us an intriguing talk on the history of the valley, the many different soil types that determine which varieties grow best where and many other aspects of the wine makers art. All enhanced by tastings of some of the wines in question.

We then moved on to Australia's oldest family-owned winery, Chateau Yalumba, with tours of the exquisitely maintained historic buildings – more wine tastings – and a delightful lunch. We were able to choose our favourite wine from the tasting to accompany our meal. A particular treat was our tour in small groups of the Hill-Smith family's private wine museum, which consisted of cellar after cellar of extraordinary wines dating back over nearly two hundred years.

We then travelled to Seppeltsfield, which has the largest array of heritage wine buildings in the country. Our wine tasting there in the private dining hall was accompanied by samples of delicious food inspired by the unique Barossa traditional artisan cuisine. Executive Chef, Owen Evans gave us an unforgettable, impassioned talk on his mission to revive the food traditions of the Valley. His story of how he recommissioned an old Smokehaus that had sat unused on the estate for 80 years to prepare smoked butters, bacon and salt as well as ageing prosciutto in old wine barrels was delightfully brought to life for us by sampling the delicious results of his endeavours.



Finally, Sunday was spent amongst the enchanting environs of the home and sheep station of Fund Members Andrew Morphett and Peter Hayward - Anlaby Station. There had been many requests from members to have a chance to revisit Anlaby to see the many restoration projects that had been completed since The Fund's last visit eight years ago. People enjoyed seeing the restored folly, the camellia house, the cucumber house, the apple house, the peacock pavilion and the many other improvements to gardens and grounds. The lamb pies at the lunch where a great hit as were the scones at the morning and afternoon teas. At the end of the visit Philip Gosse and myself had our little Olympic handing over the baton ceremony. With no baton to hand, I passed a symbolic lanyard to Philip to mark the South Australia Committee handing over the AGM to the New South Wales Committee.

Together we all experienced the past, the present and had glimpses of the future of the Barossa Valley.

The South Australian Committee – Lesley Haas Baker, Jeanette McLeod, Ann Preston–Flint, Andrew Morphett and myself wish to thank everyone who attended and we all look forward to enjoying the hospitality of NSW next year.

- Financial Sustainability: Increased funding opportunities; and continuing with second national raffle
- Members: Offering new opportunities for Members & Supporters; stable level of membership; and broadened supporter base
- Houses & Other Activities: Open / Garden Days re-commencing soon; and State based events ramping up again
- Governance & Operations: Established new Events & Marketing Committee; changes to Council membership; new website in 2021 & online event booking; and progressed many strategic plan activities
